The Faculty is a modern institution that performs undergraduate, graduate and various post-graduate study programmes in the field of Economics and Business. Since 2011 it has offered an International Business - study programme taught in English (undergraduate and graduate study), and since the academic year 2015/2016 online learning study programme Entrepreneurship. We are the first Faculty in Croatia that has its mobile application (EFRI app).

The Faculty is one of the University's most important and active components, with more than 2,000 students. The Faculty of Economics and Business in Rijeka was among the first ones to introduce scientifically based contents, courses and research work in Croatia, founded on the theory and practice of Economic association and Integration of countries and their respective economies. The Faculty collaborates with eminent foreign universities, both in the field of research and organization of joint conferences, student exchange, summer schools, and others. Throughout its entire history, the Summer School has educated more than 350 participants from over 30 countries of Europe and the world (Republic of Croatia, Belgium, France, Slovakia, Czech Republic, Ukraine, Kazakhstan, Uzbekistan, Armenia, Mexico, Slovenia, Bosnia and Herzegovina, Serbia, Canada, South Korea, Russia etc.).
