FACULTY OF ECONOMICS AND BUSINESS, UNIVERSITY OF RIJEKA

The Faculty of Economics and Business in Rijeka (EFRI) is a constituent member of the University of Rijeka. The Faculty's main activities include scientific research and teaching.

EFRI offers and conducts study programs at all levels: undergraduate, graduate, postgraduate specialist and postgraduate doctoral level.

The undergraduate studies at EFRI last 3 years, i.e. 6 semesters. Upon their successful completion, a student earns a minimum of 180 ECTS credits and is awarded the academic title: Bachelor in Economics or Business Economics.

The study programs are offered within two directions: Economics and Business Economics. From 2021/2022, the study tracks within Business Economics include: Entrepreneurship, Management, Marketing, Finance and International Business.

The Faculty also offers a fully English taught undergraduate study program in International Business.

In addition to full time study programs, EFRI also offers and conducts part-time study programs, with the possibility of studying online (study tracks: Finance, Management and Entrepreneurship).

The graduate studies at EFRI last 2 years, i.e. 4 semesters. Upon their successful completion, a student earns a minimum of 120 ECTS credits and is awarded the academic title: Master in Economics.

From 2021/ 2021, the study tracks at graduate level include: Development Economics (Economics), and Entrepreneurship, Marketing, Management, Finance and International Business (Business Economics). The Faculty also offers a fully English taught graduate study program in International Business.

The postgraduate specialist study programs last 1 or 2 years, depending on the program.

The postgraduate university (PhD) study program lasts three years and upon its successful completion the candidate is awarded a minimum of 180 ECTS credits and the academic title *doktor znanosti* (PhD) in Economics.

IMPORTANT TERMS

AAI IDENTITY – (electronic identity) – upon the enrolment into the first year of studies and upon enrolment of exchange students, each student is given an AAI identity, which is used until the completion of the study. The AAI identity is used for accessing Merlin (the e-learning platform), Eduroam wireless network within the Faculty building and other contents intended exclusively for students and faculty members. A student can get an AAI identity by contacting the Student Registry Office. A student who has forgotten his/ her AAI identity, or his/ her password, should personally contact the Student Registry Office during working hours.

X-card (student identity card) is a magnetic card containing your photo which can be used for eating government subsidized meals at Student cafeterias

and for obtaining other student benefits. More details on its uses can be found at www.cap.srce.hr.

The student card is valid as long as the student is enrolled into the Faculty, and the validity date is extended upon each enrolment into an academic year. If the card is lost or damaged, the student shall request a reissuing of the card for a certain fee.

ECTS (European Credit Transfer System) is a standardized point system used in higher education institutions within the EU. It shows student workload and achieved learning outcomes. Each individual course carries a corresponding number of ECTS credits according to required student workload i.e. engagement needed to complete and pass the respective course (class attendance, seminars, assignments, self-study, reading of assigned materials, preparing and studying for examination).



ECTS credits are distributed among all courses depending on the amount of engagement that the specific course requires in relation to other courses in the semester. The number of obtained ECTS credits also determines the degree to which a student exercises student rights (subsidized meals and accommodation, Ministry funding of tuition) and the number of ECTS credits he/she may enroll the subsequent year.

JMBAG (Academic Citizen Unique ID Number) – determines each student in a unique manner. The JMBAG is awarded upon the enrollment into a higher education institution. It can be found in the upper left corner of a student's x-card and is made up of three series of numbers.

Continuous assessment/mid-term examination – an oral or written assessment of a student's knowledge of course contents conducted during classes. Within the grading system applied at the Faculty, the grade points achieved through such assessment are calculated within the total number of grade points to be achieved during class activities (a maximum of 70 grade points) which give a student the right to sit for the final examination.

Final examination – an oral or written assessment of student's knowledge and progress conducted upon completion of lectures. Student progress achieved at the final examination is graded from 0 to 30 grade points.

Merlin – an e-learning platform based on an open-source system used for conducting classes using the unified AAI@Edu identity which is provided for all members of the academic community.

Studomat – an information system providing systematization and the registration of data. It allows students to conduct administrative tasks online, via the Internet or online kiosk: to register (apply) or withdraw the registration for examinations (if a student applies for the final examination but fails to sit for it, the final examination will be marked "null" and it will be considered that the student has exercised the right to sit for the exam), to see exam schedules, to obtain and print out student confirmations, review the data recorded in the database (personal data, data on enrolled years, enrolled courses, passed exams, due payments etc.). **Moreover, a very important Studomat function is the application for each new semester (which can also be done at the Student Registry).** The students can access Studomat using their AAI identity at the online kiosk at the Faculty (ground floor) or via any computer having internet connection at <https://www.isvu.hr/studomat/prijava>

Tutorials – additional free classes related to a specific course led by a teaching assistant (a senior student who completed the course with excellent success) in agreement with the course leader. These classes are most often held before continuous assessments and exams.

EFRI APP (a mobile application for students of the Faculty of Economics and Business in Rijeka) - available from the academic year 2020/2021!

The application will provide an overview of the study programs and courses offered at undergraduate and graduate studies, with basic data and course leaders, e-office, class schedule, news, events, implemented QR code scanner,



freshmen corner, Faculty contacts, calendar and study-related information during the COVID-19 pandemic.

SPECIAL STUDY CONDITIONS are regulated by the Regulations on Studies and Studying at the Faculty of Economics and Business, University of Rijeka

EVALUATION OF TEACHING – In order to continuously enhance the quality of studies, the students are given the opportunity to express their opinions and assess the quality of their teachers and the courses they have had at the end of each respective semester.

CLASSES

The teaching process is composed of lectures, seminars and practicums, depending on individual course curriculum. The teaching activity is conducted by teachers, assistants, external associates and guest lecturers.

Seminar classes are organized to give a more detailed insight into the topics dealt within lectures. In order to help students understand and master the course contents, the students are given seminar tasks, which, depending on the course, are done individually or as group tasks, and for which students gain a certain number of grade points.

Moreover, on most courses, the teachers engage senior students

(teaching assistants) whose task is to aid more junior students in mastering course contents.

All teachers and assistants have weekly office hours during which the students may come to see and check on his/her progress, get additional information on issues related to classwork and other course related info.

ASSESSMENT OF KNOWLEDGE AND EXAMINATIONS

At the introductory lectures, each course holder informs the students about the course, the manner in which the students will be graded (allocation of grade points) within the respective course and course prerequisites. The models of monitoring and assessing student progress as well as other materials and information needed to follow the course (list of readings, tasks, potential seminar topics, changes in schedules etc.) are posted on Merlin and as such, should be checked regularly.

The student may earn a maximum of 70 grade points for successfully completing classwork activities. Grade points are allocated through continuous assessments, seminars, class participation and any other form of evaluation of student progress envisaged by the course curriculum.

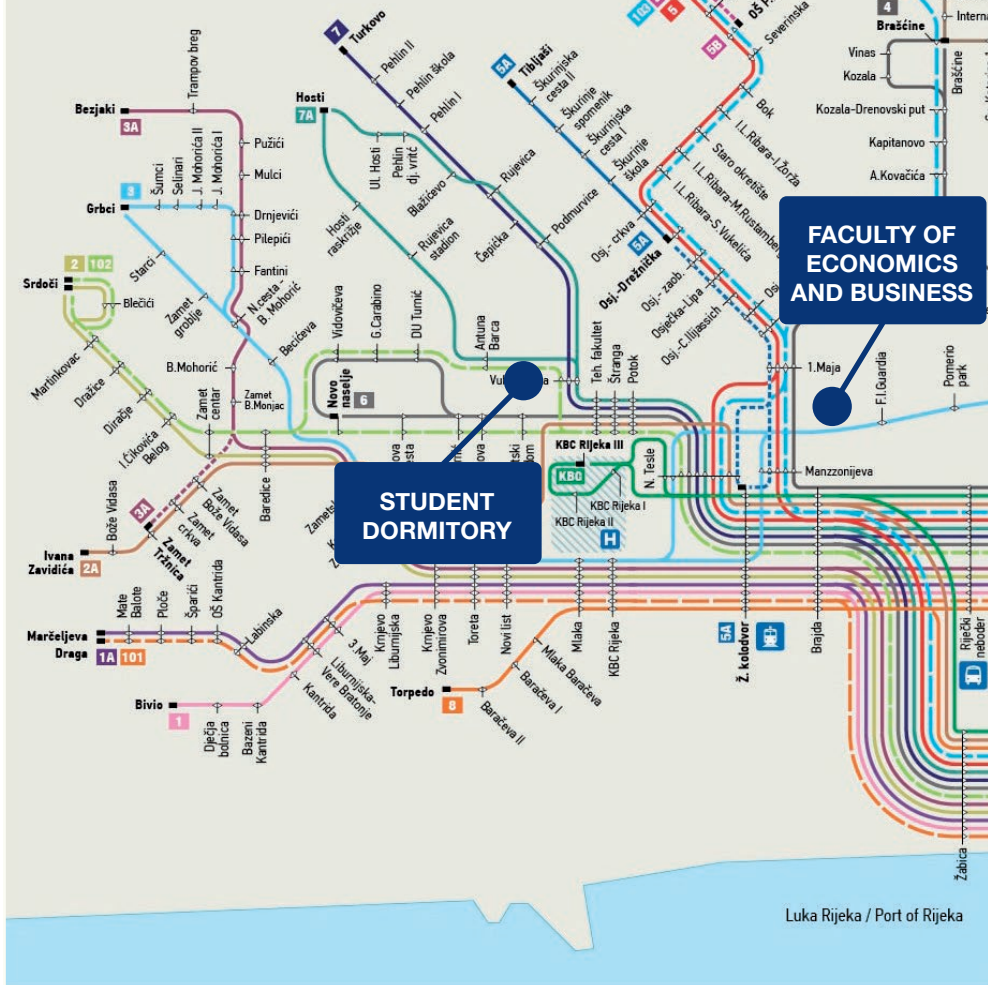

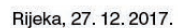

The schedule (dates) of written/oral continuous assessments/mid-terms are communicated in advance within the course curriculum published via Merlin.

WHO HAS EARNED THE RIGHT TO SIT FOR THE FINAL EXAMINATION AT UNDERGRADUATE STUDIES?

The final examination may be taken by students who have obtained at least 50% of the grade points awarded for class activities (i.e. a minimum of 35 grade points).

In order to pass the course, the student must obtain a minimum of 50% of possible grade points awarded for the final examination (i.e. 15 grade points). A student who has obtained less than 50% of the grade points awarded for the final examination i.e. has not passed the examination on 3 of the 4 possible final examination terms, has failed the course and needs to reenroll it in the following academic year.

The student needs to register (apply) for the final examinations via STUDOMAT. All examination dates as well as deadline dates for registering and withdrawing one's registration are visible

on STUDOMAT. A student may sit three times within an academic year for the final examination in each course.

The final grade is the sum of grade points achieved at the final examination and the grade points achieved during classwork. The grading system is as follows:

Obtained grade points (0-100)	ECTS grading scale	Grade
90 - 100%	A	Excellent (5)
75 - 89.9%	B	Very good (4)
60 - 74.9%	C	Good (3)
50 - 59.9%	D	Sufficient (2)
0 - 49.9%	F	Fail (1)

ERASMUS is a mobility program within which students can spend part of their studies at a foreign higher education institution or do an internship program, which significantly contributes to their independence, cultural enrichment, foreign language knowledge and the ability to work in multicultural environment. The Erasmus program allows for students to fulfill a part of their study obligations, including thesis writing, at a higher education institution abroad with which the University of Rijeka has signed an Erasmus Cooperation Agreement. During their studies abroad, the student is exempt from paying tuition fees, while the costs of his / her stay and travel are partly covered by the Erasmus scholarship. The Erasmus Mobility Call is issued by the University of Rijeka once a year on the University's web pages, for the winter and summer semester, or for the full academic year.



CEEPUS is a regional higher education mobility program aimed at enhancing mobility within individual faculty networks. The students participating in CEEPUS are exempt from paying tuition at the foreign institution, and the amount of the CEEPUS scholarship depends on the standard of living in the respective country. Countries participating in CEEPUS are Albania, Austria, Bulgaria, Bosnia and Herzegovina, the Czech Republic, Montenegro, Croatia, Kosovo, Hungary, Macedonia, Moldova, Poland, Romania, Slovakia, Slovenia, and Serbia.

STUDENT OMBUDSMAN is appointed by the members of the Student Union for a one-year period. The tasks of the Student Ombudsman include the following: informing and advising students on their rights and responsibilities and the manner of exercising their rights, participating in disciplinary proceedings against the students for the protection of their rights, taking care of the legality of the electoral conduct and other tasks

stipulated by the general acts of the Faculty.

EFRI BUDDY is a project introduced with the aim of facilitating the adjustment of freshmen to the student life. It brings together students who help the new generations of students with their own experience and knowledge in identifying opportunities and mastering the first challenges at the Faculty.

UNIVERSITY COUNSELLING CENTER (SSC) is a constituent of the University of Rijeka established to provide various forms of support and assistance to students and employees of the University. All services are free for users. There are three offices operating within the SSC: the Office for Psychological Counselling, the Office for Students with Disabilities and the Career Office.
