

Tax Policy and Fiscal Consolidation in Croatia

KEY PROJECTS

- Tax Policy and Fiscal Consolidation in Croatia
- Taxation system and socio-economic relationships in Croatia



Projects address tax policy issues tackled by the Croatian government and tax authorities in times of its fiscal consolidation that ought to ensure sufficient fiscal revenues, support long-term growth and maintain, or even increase, the equity of the tax system. The research starts with an extensive expert opinion survey about the state and perspectives of the Croatian tax system, which will be extended to include Slovenia and Bosnia and Herzegovina in order to provide for a relevant cross analysis of obtained results. The macroeconomic effects of fiscal consolidation measures in Croatia, with the emphasis on tax measures, will be analyzed at different government levels as well as the effects of tax structure on economic growth. The research will be broadened to encompass other (mostly regional) countries.

Economic and social effects of energy sector reforms on sustainable economic growth

Sustainable economic growth demands for a sustainable energy supply. In order to accomplish this, good economic governance, one incorporating energy

policy, should implement reforms that will contribute to economic efficiency and social prosperity.

The research addresses several related issues:

- 1) internal and external factors that will further influence the progress of reforms, especially in the EU;
- 2) macroeconomic performance, institutional settings, regulatory prudence and sector governance as the important wider framework;
- 3) the economic impact of energy reforms in terms of

efficiency, rate of investments, competitiveness and arowth:

- 4) the existing risk management models and development of a novel approach to assessing and hedging risks in energy markets;
- 5) the social impact of energy reforms in terms of coverage of energy services and welfare;
- 6) evaluation of the energy reforms impact on longterm and sustainable economic growth.

The goal is to shed light and to interconnect different views of the issue of management of sustainable debt, therefore deepening the understanding of the subject area, and offering preventive and curative solutions. This is necessary because insolvency, at business level, disables development and adequate business and financial restructuring, and at personal level, it destroys an individual and his/her family, whereas at social level, it creates poverty and enhances negative economic trends.

The results of the business level research should significantly improve the prediction possibilities of financial distress and will allow for a larger time-opportunity-window to exploit different restructuring options.

The results should provide the scientific knowledge of such financial management that would encourage business development by financial leverage and not threaten the survival of business entities because of inadequate capital structure.

Measuring and managing the efficiency of public health services

KEY PROJECTS

• Developing a model for measuring the efficiency of public health services

The subject of this research is to measure the efficiency of public health services in Croatia, which is carried out through various programs and projects of Public Health Institutes. The main goal of the research is to propose a model of measuring the efficiency of public health services that can also be applied to other activities in healthcare and other public services such as local government, universities etc. The model will be based on the combination of two methods (DEA and BSC) that are suitable for measuring the efficiency and effectiveness of various public services. The objectives of the project proposals are as follows: to determine the relative efficiency of each organization unit and suggest improvements for the inefficient ones (projection of the efficient frontier-DEA method), to define an integrative model for measuring the efficiency of individual perspectives within BSC framework with the aim to assess the effectiveness of achieving goals. The project seeks to answer the research question: "Does the proposed model for measuring efficiency of public health services developed on the

case of the Teaching Institute of Public Health contribute to the rationalization and long-term quality improvement of services provided.

The research aim is to explore factors that influence individuals' decision-making in the value co-creation. Furthermore, research will explore decisions made by individuals with different levels of decision-making autonomy and authority in profit and non-profit organizations, as well as decisions of individuals who are

buying products to meet their own and the needs and wants of their families. By determining the most influential factors that shape proactive and innovative decision-making process, this research will help decision-makers to make relevant decisions in order to successfully participate in value co-creation. Based on previous literature research, a significant number of factors affect an individual's decision-making. But, the value of this research is in exploring and determining influences that boost proactive and innovative decision-making. Furthermore, this research will focus on individuals contributing in value co-creation either in profit oriented activities, both on organizational and consumer market. It will also focus on individuals in

value co-creation in socially oriented activities in public institutions (government bodies, regional and local self-governing bodies) and various organizations.

Consequently this also has an impact on export competitiveness.

This research will try to answer questions on how to increase the number of new companies based on scientific innovation, how to increase the volume of their business and to increase their significance in the economy. Furthermore, we will investigate how to market these products to foreign markets. Based on this research, measures and directions will be proposed for Croatian knowledge based companies on foreign markets.

In the field of human resources development, Croatia can and must achieve national recognition in an integrated Europe. In the EU, the human resources development policy is in the domain of Member States in the increasingly present state of implementation of the knowledge economy theory in national economies and the increasingly shifting development policy from the sectoral (support to the development of particular economic activities) to the factor approach (support for the development of key development factors). This approach demands shedding light on both demographic and economic developmental influence of the population and human resources on economic growth, as well as a high degree of interfusion between the macroeconomic and microeconomic approach to research of human resources. The goal of this research is to work out and propose a scientific

base for the construction of a national strategy for human resources development in the Republic of Croatia on the basis of scientific evidence on the interdependence between development of human resources and economic development.

Logistics, funding and infrastructural developments on pan European corridors

KEY PROJECTS

Considering the financial requirements and long period of return in transport infrastructure, the EU allocates development assistance by financing the construction of transport networks. The geostrategic position of Croatia and the opportunities offered by EU

membership bring up the need to re-examine the existing mode of financing the modernization and utilization of the transport infrastructure with special attention given to absorption of EU funds.

The comparison and analyses of good EU practices, the utilization of existing transport resources, identification of absorption capacities at national and regional level, analysis of multiplier effects of development aid, and linking development and modernization of transport infrastructure with economic growth and development of the Republic of Croatia leads us to the hypothesis: The position of Pan-European corridors

X, Vb and Vc determines the possibility of increasing the competitiveness of Croatia's economy through the development of the transport infrastructure financed from EU Structural and Cohesion Funds. In complex contemporary institutional surroundings, with constant technological change and the emergence of new markets, organization theory is gaining importance.

Organization science is facing a need to understand new, different organizational and market solutions and the necessity for further development of the institutional and regulatory framework. Boundaries between markets and organizations are blurred as developmental processes become more complex. Ownership ties and strategic relationships within and between companies are unclear and publicly invisible.

The aim of this research is to analyse contemporary market forms in situations of bounded rationality, incomplete contracts and information as well as to analyse new organizational solutions and strategic decision-making in inter-organizational and intra-organizational relationships.

The goal is to implement a scientific methodology and instruments of strategy-as-practice and reach realistic and practical conclusions in order to facilitate business and ensure greater success rate competitiveness.

"Adoption of the Principles of the Croatian Qualification Framework in the Higher Education Institutions in the Field of Economics – ECONQUAL" was the project funded by the grants of the European Structural and Investment Funds, the European Social Fund under the Operational Program Human Resources Development 2007-2013 and the State Budget of the Republic of Croatia. The total value of the project was 550.000 EUR.

Faculty of Economics, University of Rijeka was the project leader and the partners were University of Zagreb, J.J. Strossmayer University of Osijek, University of Rijeka, Faculty of Tourism and Hospitality Management, Juraj Dobrila University of Pula, University of Zadar, University of Split and University of Dubrovnik.

The main objective of the project was to improve the quality of higher education of economists through the development of qualification standards and the improvement of the study programs while using the modern methods in learning and teaching. The achievement of the specific project objectives is based on the recommendations of the best international and European practices and principles of CQF.

The project has resulted with the documentation for enrollment of four Occupational Standards and Qualifications in the Registry of CQF. This project was a necessary step towards creating a sustainable higher education system in the field of economics which is intended to satisfy employers, students and professors.



Center for Local Economic Development (CLER)




The Center for Local Economic Development of the Faculty of Economics of the University of Rijeka (CLER Ltd) is active in the following areas:



The Faculty has regularly been publishing the Zbornik radova Ekonomskog fakulteta u Rijeci: časopis za ekonomsku teoriju i praksu / Proceedings of Rijeka Faculty of Economics: Journal of Economics and Business since 1971. The concept of the Journal is focused on publishing articles dealing with economic theory and economic policies. It is primarily oriented to scientific papers, but it also publishes professional articles of exceptional quality that are estimated to contribute to economic theory and practice.

The Journal has been abstracted and indexed as follows: since 1993, in JEL (Journal of Economic Literature) / EconLit (American Economic Association's Electronic Database); since 2007, in IBSS (International Bibliography of the Social Sciences),

ProQuest, Cambridge, UK and DOAJ (Directory of Open Access Journals), Lund University, Sweden; since June 2008, in CAB Abstracts, UK, and since July 31, 2008 in SSCI (Social Sciences Citation Index), Social Scisearch and JCR (Journal Citation Reports / Social Sciences Edition), Thomson Reuters, Philadelphia, USA starting with No 1/2007, while ProQuest-ABI/INFORM, Ann Arbor, Michigan, USA starting with No. 1/2006. The database SCOPUS, Elsevier, B.V., Amsterdam, the Netherlands, has started abstracting and indexing all published material of the Journal since 2008. The Journal is also abstracted and indexed by EBSCO Ipswich, MA, USA in their databases EconLit with Full Text and SocINDEX in Abstracts&Indexing with references and as of 2016, in the ERIH PLUS database.
